

## Notts County Sailing Club – NCSC

### JUNIOR OPEN MEETING 2nd JULY 2022 SAILING INSTRUCTIONS

#### 1. RULES

- 1.1. The regatta will be governed by 'the rules' as defined in the Racing Rules of Sailing 2021-2024.
- 1.2. The rules of Nottinghamshire County Sailing Club will apply unless changed by these Sailing Instructions.
- 1.3. All competitors are required to compete in compliance with the RYA Racing Charter.

#### 2. NOTICES FOR COMPETITORS

- 2.1. Notices will be posted on the notice board in the conservatory outside the Race Office.

#### 3. CHANGES TO SAILING INSTRUCTIONS

- 3.1. Any change to the sailing instructions will be posted on the notice board outside the race office no later than 1 hour before the start of scheduled racing.

#### 4. SIGNALS MADE ASHORE

- 4.1. Signals made ashore will be displayed on the flagpole near the race office.
- 4.2. When flag AP is displayed ashore, '1 minute' is replaced with 'not less than 15 minutes' in race signal AP.

#### 5. SCHEDULE OF RACES

- 5.1. The schedule of races and number of races to qualify for a series will be published in the Notice of Race.
- 5.2. No warning signal will be made after 1600 hours.
- 5.3. All classes of junior boats will start together.
- 5.4. Races held in the afternoon may run concurrently and on the same course as the NCSC Stanier series races.

#### 6. CLASS FLAG

- 6.1. Numeral 6 will be used as the Warning flag.



#### 7. SAFETY

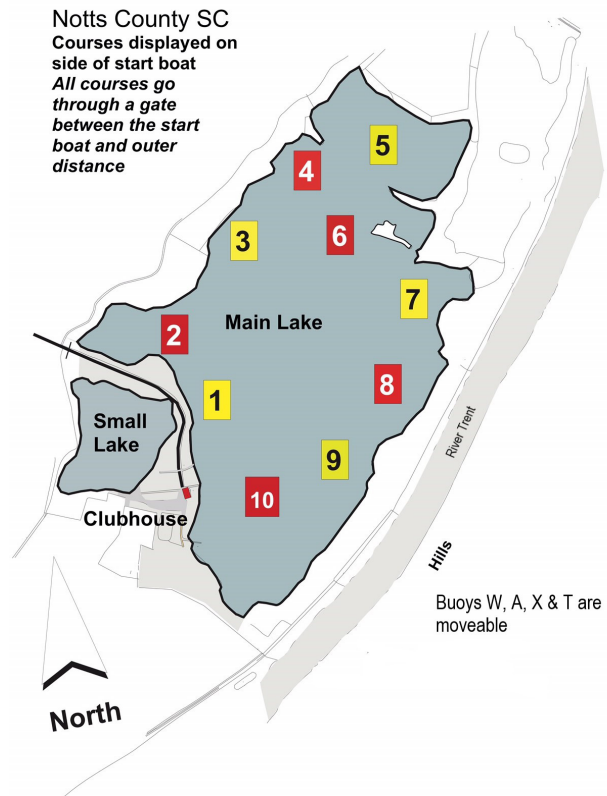
- 7.1. Adequate personal buoyancy shall be worn at all times when afloat. This amends Rule RRS40. Neither a wet suit nor a dry suit constitutes adequate personal buoyancy.

## 8. COURSE

- 8.1. The Course will be displayed on the committee boat on a course board, which will display the number of laps, and the order and direction marks are to be rounded.
- 8.2. Letter G indicates a gate. The number on a black background indicates the number of laps.
- 8.3. The Race Officer may change the course before the warning signal by breaking out flag L and displaying the new course.
- 8.4. All marks on the course board will be rounding marks
- 8.5. The race area includes the whole lake, with the exception of the small gap between the island and the main shore (see map between marks 6 & 7).
- 8.6. There may be a lead boat for the first lap of any race. The presence of a lead boat is intended as a guide and it is the competitor's responsibility to sail the correct course. If the lead boat makes a mistake, this will not be accepted as grounds for redress under RRS 62.1 (a)

## 9. MARKS

- 9.1. Marks are numbered 1 to 10 clockwise around the lake, being alternately yellow (odd numbers) and orange (even numbers). Mark 1 is adjacent to the clubhouse.
- 9.2. Additional mark W (large orange inflatable) may be used and generally acts as the first windward mark.
- 9.3. Additional marks A (white, red and orange horizontal colours), X (green and white bands) and T (red white and blue horizontal colours) may be positioned at any location on the lake.
- 9.4. The Gate G (start line) will always be a mark of the course.



## **10. THE START**

- 10.1.** The starting line will be between a staff displaying an orange shape on the committee boat and a yellow hexagonal outer distance mark.
- 10.2.** An inner distance mark may be used. If used, any boat passing between the inner distance mark and the committee boat will be deemed not to have started until she re-rounds either the committee boat or the outer distance mark and crosses the start line.

## **11. THE FINISH**

- 11.1.** The finish line will be the start line or the line between a staff on the committee boat displaying a blue flag and the nearest mark of the course.
- 11.2.** An inner distance mark may be used. If used, any boat passing between the inner distance mark and the committee boat will be deemed not to have finished until she re-rounds either the committee boat or the outer distance mark and crosses the finish line.
- 11.3.** The race committee may hail boats sailing behind the main body of the fleet in order to offer them a finishing position without needing to complete the race. Flag W may be used for this purpose. Competitors shall accept a position offered under these circumstances.

## **12. TIME LIMITS**

- 12.1.** Boats failing to finish within 30 minutes after the first boat sails the course and finishes will be scored Did Not Finish unless they or any other boats behind them are given a position under SI 11.3. This alters RRS 35. and A4.1. & A5.

## **13. SUPPORT**

- 13.1.** While racing, except in an emergency, a competing boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all competitors.
- 13.2.** No Support teams, including all support persons and support person vessels will be permitted on the water during racing.

## **14. SCORING**

- 14.1.** The low point scoring system of Appendix A will apply.
- 14.2.** Results will be calculated using the RYA Portsmouth yardstick handicap system based on average lap times.
- 14.3.** Competitors who have retired from a race must inform the committee boat or sign the declaration sheet near the official notice board located in the clubhouse.

## **15. PROTESTS AND REQUESTS FOR REDRESS**

- 15.1.** Protest forms are available at the race office located just off the conservatory at the front of the clubhouse.
- 15.2.** The time limit for protests is within 20 minutes of the last boat finishing the last race of the day or when the race committee signals no more racing today, whichever is later.
- 15.3.** Protest hearing times will be posted at least 10 minutes before the time of the protest hearing to inform all parties and witnesses.
- 15.4.** Any request to re-open a hearing shall be made within 20 minutes of the party requesting the re-opening being informed of the protest committee decision. This changes rule 66.
- 15.5.** The Advisory Hearing and RYA Arbitration procedures of the RYA Rules Disputes Procedure will be available. For these purposes an exoneration penalty of 20% shall apply although the final position of a penalised boat shall be no worse than if she had retired. At an informal hearing rules 61.2, 63.5, 63.6 RRS shall not apply.

## **16. REPLACEMENT OF CREW OR EQUIPMENT**

- 16.1.** All boats shall compete under their registered sail number. Requests for substitution of sail numbers shall be made to the Race Officer. This changes RRS 77

## **17. EQUIPMENT OR MEASUREMENT CHECKS**

- 17.1.** A boat or equipment may be inspected at any time for compliance with class rules, NOR or SI's.
- 17.2.** Penalties for breaches of class rules shall be at the discretion of the protest committee and will range from no penalty to disqualification.

## **18. INSURANCE**

- 18.1.** Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of £3,000,000.

## **19. RIGHTS TO USE NAMES & LIKENESSES**

- 20.1** Competitors and / or their Guardians automatically grant to the organising Authority (and any party to which they may delegate this right), without payment the right in perpetuity to make, use and show (including via the internet), motion pictures, still pictures or other form of media, of the event.
